## **SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT January 21, 2019**

The board of Education of the Salem School District #30, State of Arkansas, met in regular session Monday, January 21, 2019 at 6:00 p.m. in the Board room on the high school campus. The meeting was called to order by Chairman Smith.

### **ROLL CALL:**

The chairman declared a quorum present and opened the meeting for business.

The minutes from the December 17, 2019 regular sessions meeting were reviewed. Yarnell made the motion, with a second by Miller to approve the minutes as written.

Superintendent Guiltner presented the bus/vehicle report to the board. Currently we maintain twelve route buses, three trip buses and one handicap bus. Probably looking to replace the white Taraus in the near future. The fleet is in very good shape and well maintained by bus mechanic.

The districts legal liability insurance renewal was tabled until the February meeting.

Superintendent Guiltner reviewed and discussed some of the bills that are being voted on by legislation.

The board retired into executive session at 6:15 p.m.

As a result of executive session recommendation was made to extend the contract for Superintendent Guiltner by one year through June 2022. Motion was made by Coffman with a second by Yarnell.
