## SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT April 12, 2023

The Board of Education of the Salem School District #30, State of Arkansas, met in regular session Wednesday, April 12, 2023 at 5:00 p.m. in the Boardroom on the high school campus. The meeting was called to order by Chairman Coffman.

**ROLL CALL:**

Absent: Yarnell

The Chairman declared a quorum present and opened the meeting for business.

The minutes from the March 13, 2023 regular meeting were reviewed. Smith made the motion with a second by Miller to approve the minutes as written.

The Chairman called for discussion.

The Chairman declared the motion carried.

First on the agenda, Superintendent Guiltner read a resolution (attached) to recognize the 2023 Salem Lady Greyhound basketball team for their dedication to excellence and their winning season, and their many accomplishments for the year. Season record 30 wins – 4 losses. 3A-2 Conference Champions and 3A State Champions and was coached by the Arkansas Democrat Gazette Girls Coach of the Year Josh Bateman, assisted by Shane Smith and Athletic Director J.W. Blevins. Hall made the motion to accept the resolution recognizing the Sr. Lady Greyhounds with a second from Smith.

Recommendation to approve two legal transfers was requested. One student transfer form Izard County Consolidated District to Salem School District and one student from Salem School District to the Izard County Consolidated School District. The motion was made by Yarnell with a second from Miller to approve the transfers.

The board returned into open session at 6:20 p.m.
