SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT June 12, 2023

The Board of Education of the Salem School District #30, State of Arkansas, met in regular session Monday, June 12, 2023 at 6:00 p.m. in the Boardroom on the high school campus. The meeting was called to order by Vice Chairman Hall.
