SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT “CALLED MEETING” FEBRUARY 7, 2018

The Board of Education of the Salem School District #30, State of Arkansas, met in special session Wednesday, February 7, 2018 at 6:00 p.m. in the boardroom on the high school campus. The meeting was called to order by Chairman Smith.
