## **SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT NOVEMBER 20, 2017**

The Board of Education of the Salem School District #30, State of Arkansas, met in regular session Monday, November 20, 2017 at 6:00 p.m. in the boardroom on the high school campus. The meeting was called to order by Chairman Smith.

The Chairman declared a quorum present and opened the meeting for business.
